Include your company name, contact name, title, address, phone number, fax number and e-mail address. This information is required and will enable interested distributors to contact you directly.



- Forward payment information to AMTDA via fax at 301-738-9499, attention Distributor Opportunities program. Advance payment is required to initiate your Distributor Opportunity listing in AMTDA's monthly newsletter, *Tool Talk*, and to ensure its placement on AMTDA's web site.
- AMTDA accepts VISA, MasterCard and American Express. All faxed credit card orders must include credit card information and authorized signature.
